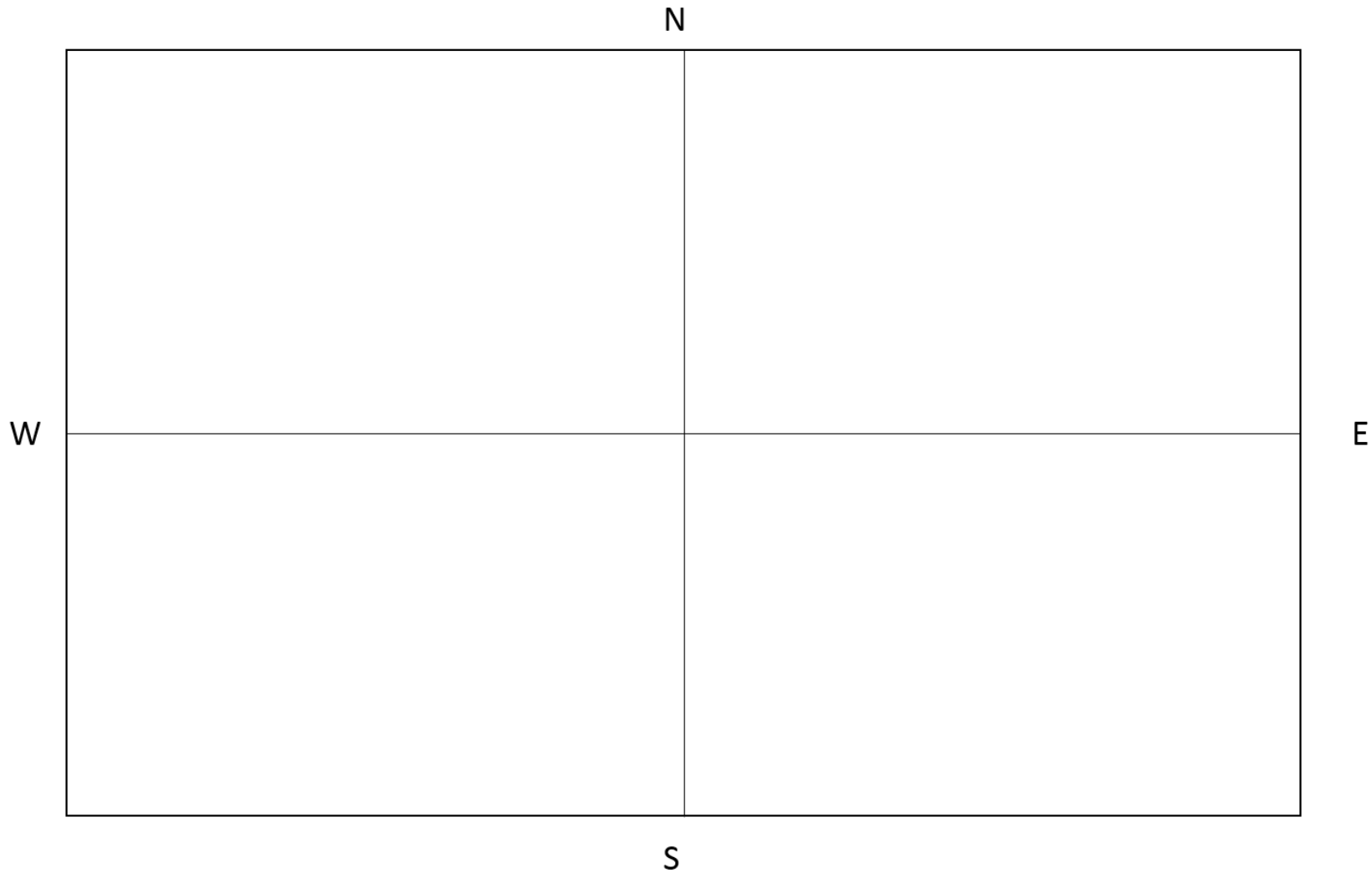

NEW BEEKEEPER/SITE REGISTRATION

PLEASE COMPLETE:

1. The date, your name, business name, mailing address, city, state, zip code, phone numbers (business, cell, and fax), and your email address. If you are a new beekeeper in Montana mark "New Beekeeper" above and enclose the one-time \$20 application fee in addition to the first year's \$19 site registration fee.
2. YOU MUST report site location as the latitude and longitude of your site (GPS Coordinates) to AT LEAST four decimal places.
3. The name of the landowner or land manager (in the case of commercial ranches, Indian reservations, state or federal land) must be legible. Please print or type this information neatly. The landowner or manager's approval signature is required for all site registrations.
4. Record the total number of colonies of bees to be located on the site.
5. DO NOT send in any form of payment until this form has been approved by the Montana Department of Agriculture. Once your sites have been approved by the department you will be notified and able to send in your payment.
