### **Tuesday, March 19, 2024:**

*Chairman Angvick called the meeting to order at 9:00 a.m. Introductions. Adoption of Agenda.  
Call for public comment, heard none.*

### **Review of November 27, 2023 Meeting Minutes**

Chairman Angvick presented the minutes of the November 27, 2023 Board Meeting.

Director Bumgarner moved, and Director Cederberg seconded the motion to approve the minutes. The motion passed unanimously.

### **Department of Agriculture Update**

Director Clark noted the department has been very busy with federal grants, awarding and managing them. She went to Cuba for a trade mission and is going to Vietnam in April. Zach Coccoli mentioned they are starting the process for an assessment on oilseeds pending a vote from producers.

### **MSU**

Darrin Boss gave the update for the university. They are filling vacancies that have been open for a while. He gave a summary of each of the openings at the research centers. Darrin talked about the building projects happening at the university.

### **Foundation Seed Update**

Brandee Johnston is done with trade shows, she attended the Wheat Quality Council meeting in Kansas where she learned a lot. A question was asked about Dagmar seed being sold out, there is still lots of foundation seed available.

### **MGGA**

Alison Vergeront introduced the new office manager Shawna Severson. The convention is scheduled for December 3-5, 2024, at the fairgrounds in Great Falls. The golf tournament is June 7<sup>th</sup> with a 40<sup>th</sup> anniversary theme. There is an opening for a policy director which can be remote and be the point person for policy.

Boyd Heilig has done some traveling lately as president of MGGA. He read the 4 policies that were approved by the national organization.

### **Industry Update**

Jake McFarlin gave his report stating the lack of export opportunities and producers holding on to grain. He mentioned China vessel cancellations. BNSF has become very slow in pickup of shuttles and having to wait 7 to 10 days for loaded cars to be taken away. He is seeing lots of barley sitting in the bins.

### **Director Reports**

Chairman Angvick – NCI & MAES Advisory Meeting– He has been participating over ZOOM, they had a financial short-fall of about \$300,000 and have had to layoff all their part-time employees & several full time positions were eliminated. They are working on recovering.

Director Conover - U.S. Wheat Associates, Barley Symposium, Wheat Foods Council – USWA will be getting more money for projects. WFC visited a cooking school. The Barley Symposium was short but informative.

Director Dahlman - U.S. Wheat Associates, KSU Milling Course, National Barley Improvement Committee – The milling course was very informative, and he learned a lot more about the process. The USWA meeting a learning experience. NBIC was all about the hill visits with breeders, industry and producers.

Director Bumgarner – National Barley Growers, US Grains Council, MSU Tech Fee Working Group – NBGA visited the hill talking about the farm bill. It was also discussed that Canada has been shipping barley to Mexico by rail through Montana for less than Montana can ship to Mexico. USGC in Guatemala was a disappointment as far as time was concerned. MSU Tech fee discussion started at the MGGA Convention and has been meeting with MSU and producers for sawfly research and taking full advantage of new varieties.

Director Cederberg – Organic Convention, Wheat Quality Council – The organic convention was held in Great Falls and was well attended. WQC was a good meeting with information from breeders. Dagmar was voted as a check for the western varieties.
