Department of Agriculture Update

Montana Wheat & Barley Committee Board Meeting Fall Board Meeting October 28-29, 2024 2

Director Clark reported to the committee about the department and the departure of Cort Jensen the staff attorney. She just returned from the Tri-Country Accord with Mexico and Canada; Mexico did not attend. The staff is busy with State Grain Lab, they are behind about three weeks. Department of Agriculture related bills will be minimal during this legislative session.

MSU Update

Dr. Bajwa talked about the Celebrate Ag Week with over 20 activities. Ag Leader of the year is Tryg Koch. Endowed Chair position has been posted.

Bradee Johnston reported that they released two new wheat varieties (MT Meadowlark & MT Ubet) and are growing foundation seed for the next growing season. Foundation seed needs to replace their combine due to age and increase in acres.

MT Grain Growers Update

Alison updated the committee about the staff, and convention. Kara Birkeland talked about the farm bill. Boyd was on MT Ag Live a couple weeks ago, he is involved with the Farm Act.

Grain Industry Rep. Update

Jake McFarlin reported that winter wheat is getting beat on price from all sides, and slow domestic demand. There are falling numbers and protein issues with wheat in isolated areas. Secondary freight markets are \$1500 - \$2000/car or 40-60 cents/bushel which exacerbates the U.S. competitive disadvantage.

Barley Consultant Update

Dave Tweet explained his roll with the committee and what he helps with. He has some ideas for more informational pieces. He talked about the barley crop results with approximately 60% acceptable on contract. New crop malt barley contracts are the \$6.00/bushel range.

Director Reports

Chairman Angvick – WTRC Field Day – Hot day it was his first time at this one. He attended the MAES Advisory Board Meeting in Shelby. His harvest report is very dry, and they get just enough rain to keep them alive. There is a lot more pulse crops being grown. Sawfly issues are always around, they were worse this year.

Director McKamey - JFMA Trade Team-Enjoyed her visit with the team.

Director Dahlman -Malteurop Field Day-Nice facility, Nisshin- good team & JFMA Trade Teams-language barrier. Hail damage and less sawfly this year. Yields were good. Seeding was good. Record lentil crop.

Director Cederberg – NARC off-station Field Day-It took place on his land. Great winter wheat crop.

Director Dailey – JFMA Trade Team-fun team. Lots of winter wheat in the ground but needs more moisture. He attended the Farmers' Union Convention in Whitefish.

Director Bradley – USWA Meeting-went to Oklahoma, Vince Peterson is retiring. Constellation Trade Team-showed them around the farm and looked at the fields, Malteurop Field Day-the tour was great, and the field tours were good. His crops were doing ok.
