Monday, November 27, 2017:

Chairwoman Conover called the meeting to order at 8:05 a.m. Introductions were made, the new director Alan Klempel introduced himself. Executive Vice President Watters announced that Blake Malcolm has resigned as the Grain Trade representative and that he will begin a search for a replacement.

Chairwoman Conover asked for public comment and Lochiel Edwards thought the committee should consider dipping into the budget reserves because of the need for cuts to the upcoming budget.

Director Myllymaki moved and Director Mattelin seconded the motion to approve the tentative agenda with changes. The motion passed unanimously.

Review of October 13, 2017 Meeting Minutes

Chairwoman Conover presented the minutes of the Fall Board Meeting.

Director O'Hara moved and Director Kolstad seconded the motion to approve the minutes with changes. The motion passed unanimously.

Montana Department of Agriculture

Deputy Director Mangold gave the update for the department. There have been some personnel losses at the department which will put a strain on the agency until those positions are filled. There are some rule changes taking place because of the last legislative session.

The department hosted a food summit in Bozeman and it was a huge success, with a lot more participants than expected.

Montana State University Update

Dr. Boyer let the directors know that the university system was spared additional budget cuts. Mike Giroux has agreed to serve as interim plant sciences department head along with his other duties.

MT Farmers Union Convention & Wheat Marketing Center Board Meeting

Director Myllymaki attended a few hours of the Farmers Union convention, it seemed to have a low turnout.

He traveled to Portland for the Wheat Marketing Center Board Meeting. An audit was done and came back as clean, they have a new website along with the new displays in the lobby. They are going through staffing changes and the stone mill was still in the box.

Transatlantic Dialog Trip

Directors Mattelin and Schock attended the event in Germany along with a few folks from MGGA and Nebraska. They toured farms in the area and had good conversations about how their operations. Both would recommend it again.

Rail Service Competition Commission

Deputy Director Mangold and Director O'Hara attended the meeting in Helena. They reported that the relationships are better and there are no problems at this point.

Mexican Craft Brewers Convention

Director O'Hara and Department of Ag Director Thomas attended the convention on behalf of U.S. Grains Council. They met with Constellation, who want a relationship with producers. The convention was very large with at least 20,000 in attendance.

Northern Crops Institute Board Meeting

Director Hinebauch traveled to Fargo for the meeting, it was the last for Mark Weber as NCI director. Montana Wheat & Barley presented him with a plaque for his service. Mark Jirik, the new director was there for the board to meet. Director Hinebauch

Field to Market

Director Mattelin reported on his meeting, there are 130 members from all sectors of agriculture. The field footprint calculator is almost complete and should have the addition of barley added shortly.

U.S. Wheat Associates Fall Board Meeting

Directors Kolstad and Conover and EVP Watters attended the meeting in Charleston, SC. Director Kolstad reported that the USWA's stand is that they do not want NAFTA to go away and will help in way to make sure that does not happen. Cuba is at a stand still and they will be closing the Egypt office soon.

Director Conover attended the Food-Aid and Wheat Quality sessions, food-aid is the 4th largest customer for U.S. wheat. Wheat quality talked about a preferred variety list for states.

EV President Watters reported that Mark Fowler is reviewing the structure of the overseas offices.
