



## Montana Department of Agriculture Celebrates Montana Cider Industry

Director Clark and representatives from the Montana Department of Agriculture (MDA) continued their focus on highlighting the diversity in

Montana's agricultural ecosystem yesterday where they joined representatives from the [Northwest Cider Association](#) (NWCA) and local cideries to celebrate a new marketing campaign for the Montana cider industry.

"From Montana's large conventional grain farms to our small acreage orchards, being a producer takes perseverance and devotion" said Director Christy Clark. "It's great to put eyes on the growth of the cider industry here in

Montana and hear from cidermakers around the state that are finding success in a true Montana value-added ag product. I commend the entrepreneurial spirit, passion, and craftsmanship of the Montana

cidermakers and cider industry."





Director Clark joined representatives of the NWCA for a tour of the Western Cider orchard in Stevensville to hear about successful apple varieties as well as challenges for the Missoula based cider brand. The group then visited one of the "Montana Cider" billboard locations that is part of a multi-month marketing campaign directed at increasing awareness surrounding the Montana cider industry. "Consumers are looking for cider" said NWCA Executive Director Emily Ritchie. "While the overall spirit industry saw a decline in the last year, the cider industry saw considerable growth."

Western Cider's flagship location and taproom is located on the banks of the Clark Fork River in Missoula, Montana. Their dream was seeded in 2012 when co-founder Michael Billingsley planted 2,500 cider apple trees in Montana's Bitterroot Valley - just south of Missoula. Now, they have nearly 5,000 trees and over 50 varieties of apples. They use those apples, as well as apples from Northwest orchards, to produce "easy going and traditional ciders" at nearly 40 cans per minute (when canning).

Also joining the tour was Kalispell based Big Mountain Ciderworks, Lockhorn Hard Cider of Bozeman, and Northwest Mobile Juicing of Lolo.




## August Gleanings from the Montana Wheat & Barley Committee

### New Directors

MWBC recently welcomed two new directors to our team. Cindy McKamey and Courtney Herzog were appointed by Governor Gianforte to replace retiring directors Charlie Bumgarner and Densie Conover, respectively. We will certainly miss Denise and Charlie and their contributions to MWBC, but we're also excited to get Cindy and Courtney on board and we're looking forward to their involvement.

### Trade Team Season

In Montana, August translates to harvest season and trade team visits. MWBC hosted three trade teams during the month all representing the Japanese wheat and flour milling industry. Japan is historically the third/fourth largest buyer of US wheat with approximately 85 percent of the hard red winter wheat and 60 percent of the hard red spring wheat originating from Big Sky Country. MWBC is always excited and motivated to welcome customers to Montana so they can meet growers; view harvest first-hand; ride on combines; tour commercial grain elevators, seed plants and flour mills; and learn about grading procedures at the State Grain Lab. Each trade team is unique in its makeup with varying levels of interest regarding facets of the industry they would like to focus on. However, a common thread is consistently their desire to meet growers and visit their farm operations. For many team members, it is their first trip to America. We roll out the red carpet and make sure they have a great time and learn as much as possible while they are in Montana. MWBC appreciates the time and effort of everyone involved from the commercial grain industry, the State Grain Lab and especially the growers who welcome the teams to their farms, shops and bin sites. While combines and tractors might seem second nature to many, the Japanese visitors are always excited and impressed when they have the opportunity to check out the equipment and go for a ride.



## **BNSF Update**


MWBC welcomed Mike McKay, Montana's BNSF ombudsman, and Matthew White, general director of agricultural products, to our office for a visit and opportunity to discuss BNSF rail operations in the state. Mike and Matt addressed performance issues related to car placement and velocity. They noted that shuttle sets offered to the marketplace were reduced from 155 to 140. Their objective is to turn fewer shuttle sets faster (velocity) while improving customer service and their overall performance. Issues related to cross border logistics with Mexico were also addressed. The slow return of empties and the damage to hopper cars while in Mexico are creating multiple problems for the railroad.

## **Challenging Growing and Harvest Season**

It seems every year is different in production agriculture, and that has not changed this year. Favorable fall seeding conditions resulted in excellent stand establishment for the 2024 Montana winter wheat crop. Mild June temperatures, average precipitation, modern farming practices and ever-improving varieties resulted in an excellent crop in terms of quantity and quality. While protein levels are below average, statewide yields have been excellent. The most recent USDA estimate of 51 bushels per acre matches record yields established in 2020 and 2023. Growing conditions changed significantly after July 8 when a blistering stretch of hot, windy weather and limited precipitation took a toll on all spring planted crops. As we approach September, harvest of spring crops continues. Unfortunately, untimely rainfall interrupted harvest on multiple occasions and caused crop damage in some areas of the state. We are all disappointed and frustrated with the hand Mother Nature dealt us during the second half of the growing season. Perhaps the silver lining is the rainfall will improve conditions as seeding is rapidly approaching.

We are all in this together. Please keep your head up, be safe and best of luck this fall.

## **USDA Announces Funding Awarded to Montana to Support Specialty Crop Growers**

The U.S. Department of Agriculture today announced over \$3.1 million in funding awarded to Montana through the Specialty Crop Block Grant Program (SCBGP). Through this program, the Montana Department of Agriculture will fund projects that strengthen Montana's specialty crop industry through marketing, education, and research.

"We are happy to once again be partnered with Montana on the Specialty Crop Block Grant Program," said USDA Under Secretary for Marketing and Regulatory Programs Jenny Lester Moffitt. "The innovative projects funded through this program will strengthen U.S. specialty crop production and markets and ensure Americans have sustained access to fresh, locally grown fruits, vegetables, and other specialty crops and support the region's specialty crop growers to help ensure their long-term success."

Through the Specialty Crop Block Grant Program, the Montana Department of Agriculture will fund 16 projects. Among the department's projects is funding to Montana State University to design and plant a teaching and outreach space at the Bozeman Horticulture Farm that demonstrates fruit crops and cultivars that perform well in Montana. Additional funded projects focus in areas such as disease management, fertilizer research, and marketing.

"Montana's producers are the backbone of our state," said Montana Department of Agriculture Director Christy Clark. "These grants support outreach efforts and vital research that directly help our farmers and ranchers to diversify, innovate, grow their operations, and drive Montana's largest industry."

The funding to Montana is part of a total of \$72.9 million in non-competitive FY 2024 funding awarded to 54 states, territories, and the District of Columbia through the Specialty Crop Block Grant Program. The funding supports farmers growing specialty crops, including fruits, vegetables, tree nuts, and nursery crops. USDA's support will strengthen U.S. specialty crop production, expand markets, and ensure an abundant, affordable supply of highly nutritious fruits, vegetables, and other specialty crops is available to all Americans.




## Montana Department of Agriculture's AgCorps

AgCorps, the AmeriCorps program housed under the Montana Department of Agriculture, is in its first year of operation and boy, has it made an impact!

AgCorps' main mission is to serve Montana by providing Ag literacy and environmental stewardship education to create resilient healthy and engaged communities. Eight members joined the program in January and will wrap up in November. From January to now, these members have assisted in recruiting over 170 volunteers, trained more than 70 individuals across different topics, taught over 700 students throughout the state, and helped build the capacity of almost 30 different organizations.

Some of the AgCorps programs include Harvest of the Month, Noxious Weeds outreach and education, and Adopt-A-Trailhead to name a few. Next year the program is expanding and partnering with more organizations across the state including Helena Food Share, Farm to School of Park County and MSU's Western Ag Research Center.



## **Montana Department of Agriculture Announces 2024 Fall Pesticide Waste Collection Events**

The Montana Department of Agriculture (MDA) is facilitating pesticide disposal events in its Central District during the week of September 16th, 2024.

Annual pesticide waste collection events have collected close to 780,000 pounds of pesticide waste from over 1,800 participants since the program's inception in 1994.

"Montana has very limited options to get rid of pesticide products," said Carli Davis of the MDA's Pesticide Disposal and Container Recycling Programs. "This program is one way of assuring the waste product is properly disposed in a manner that is also environmentally friendly."

The MDA program was designed to assist individuals with disposing of any pesticides that are unusable as originally intended, or cannot be used for any other purpose, in an environmentally responsible way. In effect, the Pesticide and Waste Disposal Program protects Montana's ecosystems and groundwater, as well as families, pets, livestock and drinking water from potentially hazardous materials.

### **2024 Pesticide Waste Collection Dates and Locations:**

- Tuesday, September 17th – Havre, MT
- Wednesday, September 18th – Great Falls, MT
- Thursday, September 19th – Lewistown, MT
- Friday, September 20th – Columbus, MT

The pre-registration deadline is September 9th, 2024. Registrations for pesticide waste collection events are accepted on a first come, first-serve basis. There is no charge for the first 200 pounds of material; amounts over 200 pounds are assessed at \$1.00 per pound, and products are weighed on site. Additional fees may apply to pesticides with dioxins or dioxin precursors.





