## PESTICIDE PRODUCT REGISTRATION INFORMATION

- ☐ **Online Application for Registration of Pesticides:** Online registrations, renewals, and payments are available through the MT Plants system. Go to [agr.mt.gov/Pesticide-Product-Registration](http://agr.mt.gov/Pesticide-Product-Registration) and review the 'Online Pesticide Renewals and Registrations' instructions for more information.
- ☐ **Application for Registration of Pesticides:** Return this form with your application fees. Use the Montana Department of Agriculture address information on the front of this form for mailing. Upon approval, a certificate for the registered products will be sent to you by email. Agent/Third party must have a letter of authorization from the registrant (if applicable).
- ☐ **Registration Period and Fee:** Pesticide registrations are valid for up to one calendar year and expire on Dec. 31 each year. If paying by check, make check payable to the Montana Department of Agriculture.
- ☐ **Product Information:** For each product to be registered, provide the following information on this application form:

**Revised Labels:** Please submit a copy of revised product labels throughout the year as they become available.

**Renewing Registrations:** Registration renewal notifications/applications for all registered pesticide products are mailed/emailed out by early November each year. Online renewals open November 1 each year. Renewals are due before January 1 of the renewal year. Montana has a two-year discontinuation policy.
